

Example " News Papers most often covered the issue in a legislative context rather than a moral or legal one, and both rarely addressed slavery reparations in the context of it's potential positive or negative effect on relations between U.S Blacks and Whites" (Zulu).

Alexander called mass incarceration The New Jim Crow because, as a result millions of African Americans locked behind bars and then relegated to a permanent second-class status denied the very rights supposedly won in the Civil Rights Movement. Also the New Jim Crow challenges the Civil Rights community to place mass incarceration at the forefront of a new movement for racial justice in America. As a form of public service announcement, the two officers promote their use of Naloxone spray accompanied by an account of how they " saved a man from a potentially fatal overdose" just the week before.

Even until this day they are still fighting for their rights. There have been cases of racism until this day. One of them has been the abuse of the police, according to news the was pronounced dead after a white police had arrested him it went really viral that there was also a big manifestation because of this dead they had started a movement called "The Black Life Matters" there was millions of people marching in the streets in every state. 


